

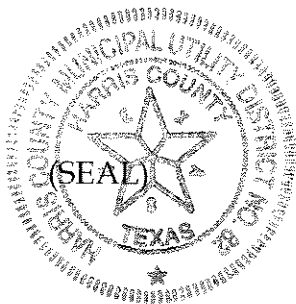
NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 82

The Board of Directors of Harris County Municipal Utility District No. 82 will hold a regular meeting on Monday, August 23, 2010, at 12:00 p.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2600, in the Colorado Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Approve minutes.
2. Comments from the public.
3. Garbage and recycling collection; disaster/emergency clean up procedures.
4. Security and review constable's report.
5. Operation of District facilities, billings, repairs and maintenance, customer correspondence, message language on water bills, delinquent accounts, permit compliance, quarterly letter to the Texas Commission on Environmental Quality regarding corrective action; manholes and sidewalks repairs; collection agreement for delinquent accounts.
6. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
7. Financial and bookkeeping matters, including payment of the bills and review of investments; budget comparison; budget for the fiscal year ending September 30, 2011.
8. Report on energy usage.
9. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
10. Discuss 2010 tax rate; set public hearing date, and authorize notice of public hearing regarding adoption of tax rate.
11. Engineering matters, including approve pay estimates, change orders, and final acceptance:
 - a. deeds, water meter and sanitary sewer easements, consents to encroachment, requests for service or utility commitment letters;
 - b. Breckenridge Forest North, Section 2 (RH of Texas);
 - i. storm water pollution prevention;
 - c. Breckenridge Park (Woodmere Development);
 - i. storm water pollution prevention;
 - d. review bids and award contract for Cypresswood Heights lift station, including emergency bypass pump;
 - e. authorize advertising for bids for water, force main and drainage to serve Cypresswood Heights Drive and school site;
 - f. Birnamwood and Cypresswood waterlines and extensions (Texas Commission on Environmental Quality notified use of surplus funds);

- g. contract for improvements to the wastewater treatment plant (Texas Commission on Environmental Quality notified use of surplus funds);
 - h. Breckenridge Forest lift station, emergency bypass pump and water plant no. 3 generator (Texas Commission on Environmental Quality notified use of surplus funds);
 - i. contract for water plant no. 1 recoating;
 - j. connection and capacity update; and
 - k. design, construction, and development in the District.

 - 13. District's website.
 - 14. Strategic Partnership Agreement with City of Houston.
 - 15. Report on action taken during the month on action authorized at the last Board of Directors meeting.
 - 16. Directors and District consultant's reports about District operations.
